JUDGE RESPONSIBILITIES			
Judge shall fulfill obligation as required pursuant to WCRL/APDT Rules and Regulations and comply with policies governing this licensed event.			
Judge shall nest courses.			
Judge shall provide to the Trial Host a copy of all courses and score sheets one week prior to the trial start date. Courses and score sheets shall be sent to the Host Contact address below.			
Judge shall judge a maximum number of _____ teams per class.			
Judge shall submit an expense report and provide receipts for all expenses to the Trial Host at the conclusion of the Judge's last assignment at the trial.			
Judge shall return both signed copies of this contract to the Host Contact at the address below no later than _____.			

CANCELLATION CLAUSE

In the event the Trial Host cancels or postpones the trial, the Judge shall be compensated, within 7 days, an amount equal to one half the total Judging fee. If re-scheduling the trial, the Trial Host must inform the Judge of the new date within 7 days. The remaining balance and all related expenses shall then be paid at the conclusion of the Judge's last assignment on the rescheduled date. If, due to prior commitment, the Judge is not available for assignment on the rescheduled date, the remaining balance of the Judging fee shall be made immediately.

STATEMENT OF CONTRACTOR RELATIONSHIP

In selecting Judges, it is important that the host group provide a written agreement to address the terms and fees to be paid to a judge for services. Judges on the "Approved Judges List" are independent contractors who have demonstrated the knowledge and skills necessary to meet WCRL / APDT qualitative standards. Internal Revenue Service (IRS) regulations provide that such contracts stipulate that the party is an independent contractor and that they are responsible for their own payroll taxes.
